# Accommodations

The 2020 CAMA Annual Conference and Annual General Meeting will be held at the Deerhurst Resort, in Huntsville Ontario from June 1-3, 2020.

CAMA has negotiated a Conference rate at the Deerhurst Resort. In order to ensure the booking process goes smoothly please read the details in full and make note of all deposit and cancellation policies for this property. We hope that this process will encourage municipalities to book only those guest rooms that are needed so that more delegates will have the opportunity to stay at the official Conference hotel. If rooms are cancelled right before the Conference it puts the Association at risk of attrition charges.

Bold granite outcroppings and dramatic terrain shifts are epitomized on the tenth signature hole with a sheer granite rock face in play along the length of the fairway.

Ranked as one of <u>Canada's top 59 public golf courses again in 2019</u> by SCOREGolf, Deerhurst Highlands continues to remain one of the top golfing destinations in Muskoka.

Start your day early at 7:30 a.m. by stepping outside your room at the Deerhurst Resort with a shuttle awaiting as the course is 1.5 km away from the hotel. You will enjoy a hot breakfast buffet at the clubhouse, followed by a visit to the driving range (if you wish) which will be open from 7:30 a.m. to 8:15 a.m. Drive away in your shared power cart at 8:30 a.m. with a shot-gun start. # Speaker: Zoran Postic, Deputy City Manager of Public Works, City of Vaughan, ON

A 2013 employee engagement survey showed the organizational culture in the City of Vaughan, Ontario's Public Works (PW) department was dominated by a lack of trust and a general feeling that staff were not respected or valued. The PW portfolio designed a multi-year program to improve the culture, beginning with two years (2014-15) of activities led by the Commissioner and Directors, including all-staff meetings to discuss the culture issues, and establishment of a Culture Change Committee made up of unionized and management staff to recommend and implement staff ideas to improve culture. At that time, managers and supervisors were enrolled in the PW





Leadership Journey which provided training in people management and leadership. The most impactful changes are now taking place as front-line staff begin to lead and model the improved culture, for example through the award-winning Vaughan Innovators staff innovation competition.

The City of Vaughan has since developed a corporate wide Masters' Leadership training program which focuses on communication, innovation and change management. This program is mandatory for all leaders at the City. CAMA was also pleased to present the City of Vaughan with the 2019 Awards of Excellence in the Professional Development category for this program.

Mr. Postic joined the City of Vaughan in 2014 in the role of director of Transportation Services, Parks and Forestry Operations (TSPFO). This staff engagement program received a 2017 John Niedra Better Practices Award from the Ontario Good Roads Association (OGRA), and, after being adopted and expanded to Community Services under the title Vaughan Innovators, the program received the Canadian Association of Municipal Administrators' 2019 Professional Development Award.

Mr. Postic has contributed tirelessly to the broader public works community by serving as program director of the OGRA Municipal Traffic Operations course, as a member of the Canadian Institute of Transportation Engineers Municipal Liaison Committee and as co-chair of the City of Vaughan's National Public Works Week (NPWW) program. Under Mr. Postic's leadership, the City's 2018 NPWW program was recognized by awards from both the OPWA and Canadian Public Works Association.

#### Speaker: Police Chief Roger L. Brown, City of Fredericton

Roger Brown has a storied and impressive career in policing, with almost four decades of experience. After a brief retirement, Chief Brown currently serves at the helm of the Fredericton Police Force. Chief Brown previously held rank of Assistant Commissioner of the RCMP in New Brunswick, and it was during that time that he had to deal with several major issues, including the shale gas protests near Rexton, New Brunswick, the murders of three members of the Codiac detachment in Moncton, and the public PTSD struggles and suicide of a member. Chief Brown took the reins at Fredericton Police almost a year after that Department also lost two officers in a tragic shooting. Chief Brown now speaks around the country about mental health issues: seeking psychological help, PTSD, and the stigma around mental illness. He shares his own story in the hopes of empowering others to seek help, and to help others.

#### **ABOUT THE SPEAKER:**

Roger L. Brown Police Chief City of Fredericton

Chief Brown joined the RCMP in 1980. Following training, he worked general duties in Rivière-du-Loup, Quebec and later in Grand Bank, Newfoundland and Labrador. He served the Force in a variety of roles, including general duty, drug enforcement, federal enforcement and as an instructor at Depot in Regina. He then went on to become a Commissioned Officer at National Headquarters in Ottawa, serving in various positions, including the Officer in Charge of the Executive/Diplomatic Protection Section, the Director of Protective Policing at the national level and as the Human Resource Officer for central Canada, including National Headquarters. In 2008, he became the Commanding Officer of the RCMP Academy (Depot Division) until his transfer to New Brunswick in 2013, where he became the 29th Commanding Officer of the RCMP in New Brunswick (J Division). On June 4th, 2016, after a distinguished 36 year career, then Assistant Commissioner Brown retired from the RCMP. On June 11, 2019, Roger Brown donned a different uniform and became the Police Chief of the Fredericton Police Force.

In 2018, Chief Brown was named as one of 150 Difference Makers in Mental Health in Canada by the Canadian Centre of Addiction and Mental Health.
