## **ONE-PAGE SUBMISSION**

Attach a one-page submission (font size 12) outlining the nature of the nominee's support for CAMA using the following criteria. The points used for evaluation are also outlined below in the table for your information:

- <u>Length of time served in local government as a CAO or direct report to a CAO</u>: To be eligible for the award the nominee must have a minimum of ten years of service as a CAO or a direct report to a CAO.
- <u>Length of Service</u>: To be eligible for the award the nominee must currently be, or have been, a CAMA member in good standing for no less than ten years.
- <u>Contribution to CAMA</u>: It would be expected that a nominee will have made a contribution to the Association which goes beyond the normal role of an ordinary member. Areas of contribution might include the following categories with an explanation of the impact on the work that they did:
  - <u>Board Work.</u> Played a leadership role in the organization as a Board member or participated on a Sub-Committee to animate CAMA services and offerings, or another activity.
  - <u>Membership Drive Work</u>. Activity engaged in outreach and promotion to extend CAMA's reach.
  - <u>Professional Development Work</u>. Played a critical role in professional development opportunities, was an active leader/ambassador at the Conference, etc.
  - <u>Leadership in Local Government Administration</u>. Has demonstrated leadership and competency and has had an impact in municipal leadership and the local government administrative profession while promoting CAMA.
- <u>Ambassador to CAMA and Local Government</u>. The nominee, as an ambassador of the Association must exhibit excellence in both personal and professional reputation: Should display good character; general attitude and behaviour; show dedication to the values of CAMA; have commitment to the principles of CAMA; and display good leadership and role modelling which reflects credit upon CAMA.
