I am currently the Chief Administrative Officer of the Town of Saugeen Shores, one of the fastest growing rural municipalities in Ontario, in the heart of Canada's Clean

Energy Frontier. That growth has quickly brought economic, administrative, and cultural changes to our community, alongside an infrastructure "reckoning" that so many municipalities are facing right across the country. This confluence of challenges has meant using organizational and fiscal discipline to find ways to move Saugeen Shores forward, while showing transparency and accountability.

I have geared my education to fulfill those solutions. In addition to being a Certified Municipal Officer (CMO), I earned a Master's Certificate in Public Management from York University's Schulich School of Business and a Certificate in Managing & Leading in a Municipal Environment from Loyalist College.

I am passionate about helping guide communities to a more prosperous future through municipal leadership. With 25 years of public sector experience, I work to create environments of high organizational performance that lead to creative and innovate solutions to today's challenges.
