Great Pacific Adventures – Whale Watching

Cost: \$75.00/person

The spectacular Inner Harbour of Victoria, British Columbia, is the home base of the operations for Great Pacific Adventures Incorporated. Locally owned and operated, this company are certified outdoor adventure experts that provide informative insight and in-depth knowledge of Victoria's surrounding unique habitat, combined with an unsurpassed nature-viewing experience. The waters and islands of Juan de Fuca Strait, Haro Strait and the Strait of Georgia are a part-time home to three groups of "resident" whales, commonly known as "pods" of orca, or "killer" whales. Pods of whales are groups of families and individual whales that live and thrive mainly on salmon and other species of fish found in the waters of the Pacific Northwest. On occasion, "transient" orca whales are encountered on an individual or group basis, and are mainly dependent on other mammals, such as seals and sea lions as a core food source. Pods can gather together to form "super-pods" and have reached numbers in excess of eighty whales at a time! What would be a trip to Victoria without an exciting whale watching adventure? This tour will depart from the Inner Harbour which is a short walk from the Fairmont Empress Hotel.

Kayaking Excursion

Conveniently located on the Selkirk Waters of the Victoria Harbour and along side the Galloping Goose and Lochside Trail system (which is a pleasant walk from the Fairmont Empress Hotel) there are bicycle and kayaking rentals with or without a tour.

You can opt to begin your adventure from the dock in the protected waters of the Selkirk Waterway. Paddle towards Victoria's historic Inner Harbour and see Victoria from a seal's perspective. Become immersed in the hustle and bustle of a busy working harbour and get up-close and personal with the seaplanes and harbour seals. The experienced guides will unravel Victoria's historic web from the collapse of the Bay Street Bridge to the sinking Empress Hotel. This is a 2.5-hour tour with a group no larger than five paddlers. Cycling Tour

Cost: \$45.00/person

This tour is for the avid cyclist! Suggested cycling tours can include a tour through "wine valley" which is a fun way to visit the Saanich Peninsula with its rich farming and agricultural history. The area is ideal to cycle with modern open country roads with some designated cycling lanes. Its relatively flat, and the sun, not only adds to the magic of the grapes, but to the warmth of the day, and the surrounding scenery. In the distance the golf islands create the back drop. The surrounding fields yield everything from seasonal daffodil farms to rows of strawberries, blueberries and lots more, which are available in the roadside stands - and of course, the vineyards.

There are many ways to explore the wineries in this area but as the days/hours of operation differ at the different wineries, the knowledgeable guides will drop you in a preferred area with a route that will work for this particular day. The Church and State Winery is usually the first stop where you will receive direction instructions to find the wineries and of course the bikes to ride.

You will return on the Lochside Trail, past Mattick's Farm and another VQA wine shop. The trip back through the Blenkinsop Valley is another relaxing photo opportunity wherein you will ride across the Selkirk trestle to end your trip at Selkirk Station Bicycle and Kayak Shop.

Workshop - Why People Don't Do What We Want

Robert Cooke, Executive Team Coach

As leaders we rely on others to fulfill our expectations. Some team members do this better than others. The purpose of this workshop is to explore the three basic reasons that people don't do what we want them to. It will be a combination of input, self-analysis and discussion. The session will focus on the three reasons for lack of desired performance:

- 1. They don't know what I want;
- 2. They can't do it; and
- 3. They won't do it

During the session participants will assess the extent to which they believe their people, who are not performing adequately, are clear on expectations and accountabilities and what leads them to this conclusion. We will also explore how participants are assessing the capability of people who are not performing and the nature of formal and informal reward and recognition systems in place and how they impact people's desire to perform.







About the speaker:



Robert Cooke is an executive and executive team coach who, over the last 25 years, has helped executives and executive teams to improve their personal, business and team performance. Through one-on-one coaching, the design and facilitation of team sessions and the provision of advisory support, he has helped executives to focus on the right issues, clarify business direction, develop and implement business transformation initiatives and improve personal, leadership and business performance.

Rob also brings extensive consulting experience in the design and implementation of shared services and alternative service delivery initiatives. He is the co-author of the highly successful book, "Shared Services: Mining for Corporate Gold", (Prentice Hall 2000) and the author of multiple papers focused on enhancing alternative service strategies and performance. <u>Dockside Green - Tour the World's Most Sustainable Development and Savour a Coffee Beside the Sewage Plant</u>

Host: Madonna Blunt, Operations Coordinator, Dockside Green

Time: 1.5 hours

Take a tour of the world-renowned Dockside Green Development, with its first two phases completed in early 2010, ranks as the most environmentally friendly development in Canada. The existing residential buildings, with a total of 264 units, have earned the highest scores under the Canada Green Building Council's LEED standard. The community as a whole has garnered top LEED Platinum ranking which was awarded the highest LEED point total in the world (Phase I Platinum Rating: 63 points of a total of 70).

The 15-acre brownfield development, which is 23 per cent complete and backed by credit union Vancity, also includes a privately owned district biomass plant for heat and hot water. The site generates its own heat through a cogeneration plant, treats its own sewage and reuses all wastewater throughout the site and contains over \$6 million of community amenities, including social housing.

The sewage plant cost \$3 to \$4 million to build and about \$300,000 a year to operate. It occupies four levels, including 30 feet underground, and is now running at about 25 per cent capacity. The facility was engineered by consultants WorleyParsons, and is operated by Corix.

Hartland Landfill and Learning Centre: Foundation Organics Compost Operation and Gas to Electricity Plant.

Host: Drew Fafard, Manager – Hartland Operations, Capital Regional District

Time: 2.5 Hours

Take a tour of the active face of the Hartland Landfill and stop in at the learning centre to learn about the Capital Region's organic compost program. The Capital Region has also capitalized on the methane gas produced when oxygen mixes with decomposing garbage. Since 1991, Hartland has been collecting this gas using a network of wells and pipes. Until recently, the landfill gas was burned using a flare to reduce GHGs.

In 2003, a landfill gas-to-electricity plant was built next to the flare station to utilize the methane in the landfill gas to produce electricity. The facility now produces close to 1.6 megawatts of green power – enough electricity to supply about 1,600 homes.

A public-private partnership was undertaken to develop the landfill-gas-to-electricity plant. Maxim Power Corporation built and operates the facility and sells the power to BC Hydro. The Capital Region District owns 70% of the equipment and leases it back to Maxim. In return for the landfill gas, Maxim pays a royalty to the CRD. Maxim develops, owns and operates other environmentally-sound power plants and commissioned a similar facility at the City of Vancouver landfill in Delta.





City Centre Park and Westhills Development - Langford's Highly Successful and Livable Developments.

Host: Mr. Jim Bowden, City of Langford Administrator; Mr. Mike Leskiw, Manager of Parks and Recreation for the City of Langford; and Mr. Rohan Rupf, Marketing Manager for Westhills



Tour the state of the art \$25 Million facility geared to one stop recreation for the citizens of Langford and hear the story of how this four year project came to fruition. Delegates will see the combination (NHL size) ice arena and bowling centre, Family Fun Park and Playzone, Bear Mountain Stadium and Goudy Field (home to Rugby Canada) which caps off the four year build-out of City Centre Park.

In the Community Centre's Arena, roller and ball hockey leagues play for glory. Lacrosse teams duke it out on the dry floor. And the Eves of Destruction, Vancouver Island's own roller derby league, compete for points and bruises.

From City Centre Park, continue on to the neighbouring Westhills development lands encompassing 209 hectares (517 acres) of rolling sloped lands, knolls, and rocky outcroppings in the City of Langford.

The Westhills Master Plan embodies the goal of creating a unique, large-scale master-planned community based on principals of social and environmental sustainability. Major guiding factors of the design and implementation of Westhills are: considerations of location, alternative transportation modes, environmental preservation, community agriculture, water efficiency, energy and atmosphere (with geo thermal district energy), materials and resources, and indoor environmental quality. These characteristics are demonstrated in the creation of approximately (6 million square feet) 6000 new residential units, with supporting commercial, civic and educational facilities.
